

## **POLICY IHCF – Communicable Diseases**

Student health is first and foremost. If a student is excluded from school activities, it will be in accordance with the guidelines established by Alberta Health.

## **PURPOSE**

To support the school community and foster a positive and healthy school environment where everyone is treated with equality, dignity and respect.

## **BACKGROUND**

Communicable diseases are diseases which can be spread to others. There are two types – viral and bacterial. Some are more serious than others. Communicable diseases can be spread in different ways depending on the particular disease (direct contact, airborne, water/food, blood, body fluids). Many are reportable to the local Public Health Nurse/Medical Officer of Health.

# **GUIDELINES AND PROCEDURES**

- 1. If a student has a common disease, follow the Alberta Health Services Common Diseases Summary. (See Exhibit 1.)
- 2. Notifiable diseases are monitored and controlled by the Communicable Disease Regulation under the *Public Health Act*.
- 3. If a Principal is advised of a confirmed case of a communicable disease by an AHS Health Inspector or by a nurse with the Centre of Disease Control, then the following protocol will be followed (this protocol also applies to playschools and daycares in the school):
  - a) Principal receives confirmation from a Health Inspector or CDC Nure,
  - b) Directives are provided by AHS for the Principal to communicate, if necessary.
  - c) Principal forwards confirmation to the Superintendent.
  - d) Superintendent or designate distributes advisory to other schools, attached playschools and daycares, if required.
- 4. If a student is ill with fever, rash, cough, vomiting or diarrhea or is generally unwell:
  - a) the student will be isolated from the general student population; and
  - b) the Principal shall inform the parents and request that the student be excluded from school until he/she has consulted with a health care provider or the student is better.
- 5. The identity of a student infected with a communicable disease shall be protected.
- 6. Everyone (volunteers, students and staff) must use hygienic practices in handling blood and body fluids (see Exhibit 2).
- 7. The Policy Review Committee shall review this policy annually to reflect new medical information as it becomes available.
