



ELECTORAL WARDS AND TRUSTEES

BYLAW NO. 01-2021

OF THE

The Evergreen Catholic Separate School Division (THE “SCHOOL DIVISION”)

A Bylaw of the Evergreen Catholic Separate School Division in the Province of Alberta, relating to the arrangement of the electoral wards and trustee(s) to be elected to each ward.

Within the stipulations of Ministerial Order 41/94, which established The Evergreen Catholic School Division and subsequent Ministerial Orders 003/98, 012/2004, 027/2005, 006/2007, 013/2020, 005/2021 the Board provides for the nomination and election of trustees within the School Division by wards and electoral subdivision.

Whereas Section 76 (1) of the *Education Act* of Alberta provides that the Board of Trustees of the School Division (the “Board”) may by bylaw provide for the nomination and election of trustees by wards and determine the boundaries of the wards, or provide for the election of trustees by the general vote of the electors.

Whereas Section 76 (2) of the *Education Act* of Alberta provides that the Board shall provide a copy of a bylaw passed under this section to the Minister after the bylaw is passed and before December 31 in the year prior to an election year.

Now Therefore, in accordance with Section 76 of the *Education Act*, The Board of Trustees establishes the wards and provides for the nomination and election of trustees in the wards and electoral subdivision as follows:

1. **Ward 1 (The Stony Plain Ward)** shall be comprised of all lands included in the jurisdiction of The Stony Plain Roman Catholic Separate School District No. 151.

Township 50, Range 27, West of the 4th Meridian

Sections 31 and 32; South half and Northwest quarter of Section 33; Those portions of Sections 28 to 30 inclusive lying North of The North Saskatchewan River.

Township 50, Range 28, West of the 4th Meridian

Sections 26, 35, and 36; Those portions of Sections 23 and 25 lying North of The North Saskatchewan River.



Township 51, Range 27, West of the 4th Meridian

Sections 4 to 9 inclusive; Sections 15 to 21 inclusive; Sections 27 to 34 inclusive; South half and Northwest quarter of Section 22; South half of Section 23; Northwest quarters of Sections 10 and 14.

Township 51, Range 28, West of the 4th Meridian

Sections 1, 12, 13, 24, 25, and 36.

Township 52, Range 27, West of the 4th Meridian

Sections 3 to 9 inclusive; Sections 17 to 20 inclusive; Sections 30 and 31; West halves of Sections 10, 16, 29, and 32; Southwest quarter of Section 21.

Township 52, Range 28, West of the 4th Meridian

Sections 24, 25, and 36; East half of Section 1; Northeast quarter of Section 13.

Township 53, Range 27, West of the 4th Meridian

Section 6.

Township 53, Range 28, West of the 4th Meridian

Section 1.

Township 50, Range 1, West of the 5th Meridian

Sections 25 and 26; Sections 31 to 36 inclusive; Those portions of Sections 22, 23, 24, 27, 28, 29, and 30 lying North and East of The North Saskatchewan River.

Township 50, Range 2, West of the 5th Meridian

Those portions of Sections 35 and 36 lying North and East of The North Saskatchewan River.

Township 51, Range 1, West of the 5th Meridian

Sections 1 to 19 inclusive; Sections 30 and 31; North half of Section 20; East half of Section 24; Southwest quarter of Section 23.

Township 51, Range 2, West of the 5th Meridian

Sections 1 and 2; Sections 11 to 14 inclusive; Sections 23 to 27 inclusive; Section 29; Sections 31 to 36 inclusive; That portion of Section 30 lying North of The North Saskatchewan River.

Township 51, Range 3, West of the 5th Meridian

Sections 25, 26, 35, and 36; East half of Sections 27 and 34; Those portions of Sections 23, 24, and the East half of Section 22 lying North of The North Saskatchewan River.



Township 52, Range 1, West of the 5th Meridian

Sections 6 and 7; Sections 16 to 22 inclusive; Sections 25 to 36 inclusive; North half and Southeast quarter of Section 24; North half of Section 23; Northwest quarter of Section 15.

Township 52, Range 2, West of the 5th Meridian

Sections 1 to 18 inclusive; Sections 20 to 29 inclusive; Sections 32 to 36 inclusive; North half and Southeast quarter of Section 31; East halves of Sections 19 and 30.

Township 52, Range 3, West of the 5th Meridian

Sections 1, 2, 11, and 12; East halves of Sections 3 and 10.

Township 53, Range 1, West of the 5th Meridian

Sections 1 to 10 inclusive; Sections 16 to 22 inclusive; Sections 26 to 29 inclusive; Sections 32 to 35 inclusive; South half and Northwest quarter of Section 15; West half of Section 25; Southwest quarters of Sections 11 and 36.

Township 53, Range 2, West of the 5th Meridian

Sections 1 to 24 inclusive; Sections 29 and 30.

Township 53, Range 3, West of the 5th Meridian

Sections 18, 19, and 30; Northwest quarter of Section 29; That portion of Section 7 not included in The Wabamun Lake; That portion of Section 6 known as The Indian Reserve No. 133B.

Township 53, Range 4, West of the 5th Meridian

Sections 11, 13, and 14; Sections 23 to 26 inclusive; Those portions of Sections 1, 2, and 12 not included in The Wabamun Lake.

Township 54, Range 1, West of the 5th Meridian

Sections 2 to 5 inclusive; Sections 8 to 11 inclusive; West halves of Sections 1 and 12.

2. **Ward 2 (The Spruce Grove Ward)** shall be divided into two (2) electoral subdivisions as follows:

a. **Spruce Grove Electoral Subdivision No. 1** shall be comprised of the following lands:

Township 52, Range 26, West of the 4th Meridian

Section 19; Sections 26 to 35 inclusive; North half of Section 18.

Township 52, Range 27, West of the 4th Meridian

Section 15; Sections 22 to 28 inclusive; Sections 33 to 36 inclusive; North half and Southeast quarter of Section 21; North halves of Sections 13 and 14; East halves of Sections 16, 29, and 32; Northeast quarter of Section 10.



Township 53, Range 26, West of the 4th Meridian

Sections 2 to 6 inclusive; Sections 9 to 11 inclusive; Sections 14 and 16; Section 21; South half and Northeast quarter of Section 8; Southeast quarter of Section 17; Those portions of Sections 15 and 23 lying South of The Big Lake; That portion of Section 22 lying West of The Big Lake; Those portions of Section 27 lying South and West of The Big Lake.

Township 53, Range 27, West of the 4th Meridian

Sections 1 to 5 inclusive; Sections 9 to 11 inclusive; Section 16; Section 21; Sections 25 to 36 inclusive; North half and Southwest quarter of Section 22; West halves of Sections 12 and 15; North halves of Sections 23 and 24; Those portions of Section 8 which lie South of the South limit of the main highway as shown on Plan 812 0573 excepting the North South government road allowance adjoining the West boundary of Section 8.

Township 53, Range 28, West of the 4th Meridian

Portions of Sections 25 and 36.

Township 54, Range 27, West of the 4th Meridian

Sections 4 to 9 inclusive.

Township 54, Range 28, West of the 4th Meridian

Portions of Sections 1 and 12.

Township 53, Range 1, West of the 5th Meridian

North half and Southeast quarter of Section 36; East half of Section 25.

Township 54, Range 1, West of the 5th Meridian

East halves of Sections 1 and 12.

- b. **Town of Devon Electoral Subdivision No. 2** shall be comprised of the following lands:

Township 50, Range 26, West of the 4th Meridian

Sections 27, 28, and 34; South half and Northwest quarter of Section 26; South half and that portion of the North half of Section 33 lying East of The North Saskatchewan River; That portion of the Northeast quarter of Section 26 lying West of the Ravine; That portion of the Northwest quarter of Section 35 lying West of The North Saskatchewan River; That portion of the Southwest quarter of Section 35 lying South and West of The North Saskatchewan River.

Township 51, Range 26, West of the 4th Meridian

Those portions of Sections 1, 2, and 3 lying South of The North Saskatchewan River.



3. **Ward 3 (The Westlock Ward)** shall be comprised of all lands included in the jurisdiction of The Westlock Roman Catholic Separate School District No. 110.

Township 57, Range 27, West of the 4th Meridian

North half and Southeast quarter of Section 34; North half of Section 33; Northwest quarter of Section 35.

Township 58, Range 25, West of the 4th Meridian

Sections 7 and 8; Sections 17 to 20 inclusive; Section 30; South half and Northwest quarter of Section 31; West half of Section 29; Southwest quarter of Section 32.

Township 58, Range 26, West of the 4th Meridian

Sections 4 to 36 inclusive; Northwest quarter of Section 3.

Township 58, Range 27, West of the 4th Meridian

Sections 3 to 5 inclusive; Sections 8 to 17 inclusive; Sections 20 to 29 inclusive; Sections 32 to 36 inclusive; North half and Southwest quarter of Section 2; Northwest quarter of Section 1; Those portions of Sections 6, 7, 18, 19, 30, and 31 lying East of the 5th Meridian.

4. **Ward 4 (The Hinton Ward)** shall be comprised of all lands included in the jurisdiction of The Hinton Roman Catholic Separate School District No. 155.

Township 48, Range 26, West of the 5th Meridian

Section 25; Section 36; Those portions of Sections 12, 13, 23, 24, 26, 32, 33, 34, and 35 lying North and East of The Jasper National Park.

Township 49, Range 26, West of the 5th Meridian

Sections 1 to 4 inclusive; Sections 8 to 36 inclusive; Those portions of Sections 5 to 7 inclusive lying East of The Jasper National Park.

Township 49, Range 27, West of the 5th Meridian

Sections 23 to 27 inclusive; Sections 34 to 36 inclusive; Those portions of Sections 12, 13, 14, 15, 21, 22, 28, and 33 lying East of The Jasper National Park.

Township 50, Range 25, West of the 5th Meridian

Sections 6 and 7; Sections 18 and 19; Sections 25 to 36 inclusive.

Township 50, Range 26, West of the 5th Meridian

Sections 1 to 36 inclusive.



Township 50, Range 27, West of the 5th Meridian

Sections 1 to 3 inclusive; Sections 9 to 17 inclusive; Sections 19 to 36 inclusive; Those portions of Sections 4, 5, 7, 8, and 18 lying East of The Jasper National Park.

Township 50, Range 28, West of the 5th Meridian

Section 25; Sections 35 and 36; Those portions of Sections 13, 24, and 26 lying East of The Jasper National Park.

Township 51, Range 24, West of the 5th Meridian

Sections 1 to 36 inclusive.

Township 51, Range 25, West of the 5th Meridian

Sections 1 to 36 inclusive.

Township 51, Range 26, West of the 5th Meridian

Sections 1 to 36 inclusive.

Township 51, Range 27, West of the 5th Meridian

Sections 1 to 36 inclusive.

Township 52, Range 24, West of the 5th Meridian

Sections 1 to 36 inclusive.

Township 53, Range 24, West of the 5th Meridian

Sections 1 to 36 inclusive.

Whereas Section 78 of the Education Act provides the Minister shall specify for each board the number of trustees, being no fewer than 3, to be elected to the board. The Minister may vary the number of trustees to be elected for each school division. The Board of Trustees of The Evergreen Catholic Separate School Division hereby resolves:

1. The number of trustees to be elected for each ward is as follows:
 - a. Two (2) trustees shall be elected at large in Ward 1 – The Stony Plain Ward.
 - b. Four (4) trustees shall be elected in Ward 2 – The Spruce Grove Ward as follows:
 - i. Three (3) trustees shall be elected in The Spruce Grove Electoral Subdivision No. 1.
 - ii. One (1) trustee shall be elected in The Devon Electoral Subdivision No. 2.
 - c. One (1) trustee shall be elected at large in Ward 3 - The Westlock Ward.
 - d. One (1) trustee shall be elected at large in Ward 4 – The Hinton Ward.



As set out in Section 76(2.b) of the *Education Act*, this bylaw does not apply to or affect the composition of the board until the date of the next general election to which the bylaw applies.
